



Notarized Translation

A notarized translation is a certified translation that has been declared by a person with certain qualifications (e.g. certified public translator) that this translation is not different from the original text, and, signed and sealed by a notary public.



Issuance of Attestation

Attestation of Translation is a document recognized under the Licensed Administrative Agent Act, and is a certificate that proves that a certified public translator has signed and declared that they have translated it and the translation is the same as the original text.



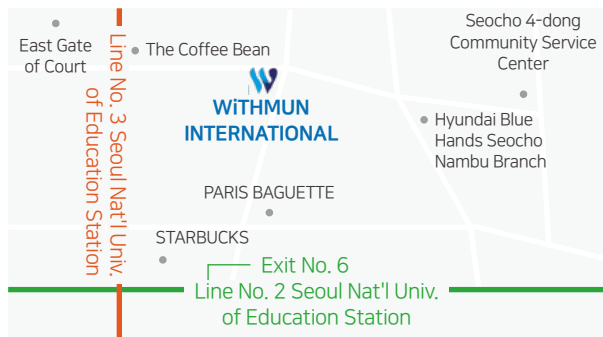
Apostille

An Apostille is a certificate that authenticates the origin of a public document. It is issued by a country that is party to the Apostille Convention to be used in another country which is also a party to the Convention.



Consular Authentication

Consular authentication, a.k.a. consular legalization, refers to a consular practice ensuring authenticity of the very last signature and the seal affixed to a document related to the application from a natural person, legal person or other organization for use overseas

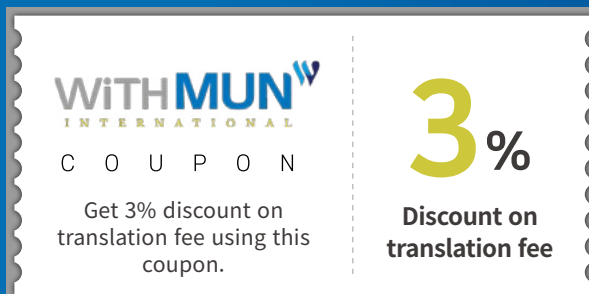

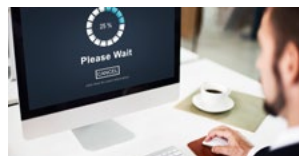

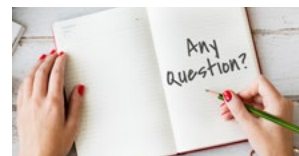
